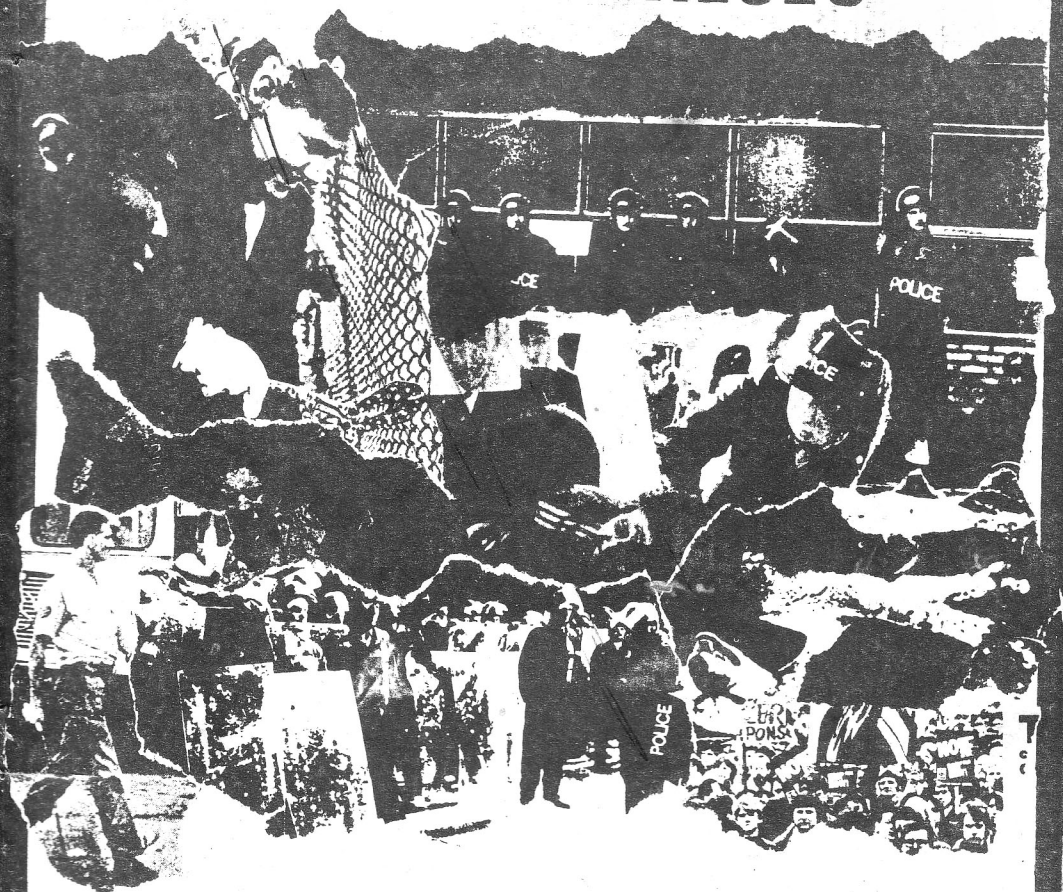

# AIDS

AND VIVISECTION»HUMAN STUPIDITY,  
IN THE NAME OF INCREASED PROFITS,  
AGAIN CREATES SUFFERING AND PAIN.

**A**ids, something which threatens, not only to fundamentally change our lifestyles but to kill us. A disease which has the potential to cause a disaster to the human race. Some predict that its effect on humanity will be more far-reaching & worse than the Bubonic plague, or Black Death, which wreaked havoc during the 19th century, but whatever its effects will be, it causes death and suffering to millions of people and therefore must be opposed and stopped in as many ways as possible. Many countries' top scientists work hard to combat AIDS and a lot of money is poured into work such as prevention and education but very little take much effort to recognise the cause of AIDS and ask why it has occurred. Vivisection is wholly responsible, not a bacterium from outer space, or a freak accident between a man and a monkey(!?) but through human blunder and profiteering which has been the cause of so much death throughout history. In September 1986 there were 26,566 reported cases of AIDS in the USA and an estimated  $\frac{1}{2}$  to one million infected carriers of the disease—it is predicted that by the year 1991 AIDS victims will be dying at a rate of 50,000 a year. Estimates for other parts of the world are even more frightening. Since AIDS will become deadly and seen as omnipotent as nuclear weapons due to government mistake it is imperative that the truth be revealed.

## SCIENTIFIC COCK-UP

There are 2 forms of AIDS—Simian AIDS which naturally occurs in monkeys and the second form of AIDS which afflicts humans. These 2 forms are largely unconnected apart from the fact, that due to human meddling and ignorance, they were created in laboratories, as they are unnatural, and the latter strain is responsible for the holocaust which is imminent. Doctors are, apparently, now doing their utmost to reduce the factors which make the transmission of AIDS possible but this has not been the case with Simian AIDS. All over the USA during the 60's and 70's vivisectionists were deliberately

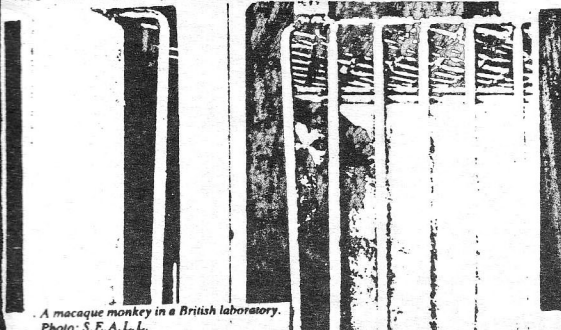

As a direct result, human AIDS was developed and the vivisection community must stand accused of creating the worst public health disaster in recent history.

## VERY DODGY INDEED

Several theories have been put forward about the origins of AIDS but obviously many are just lurid fabrications invented by the vivisection fraternity to help obscure the deadly mistakes that were made. They say that the AIDS virus is a variation of one virus normally found in the African Green Monkey which crossed the species barrier to man but other work and evidence provided disproves this theory as bullshit though the virus does seem to be more common in Africa than in any other country due to the lack of screening blood for AIDS and the other usualities such as sex etc.

It is obvious through the complete blindness and incompetence of vivisection that they have the power to create even more frightening diseases to afflict mankind. There are several cases:— "PORT



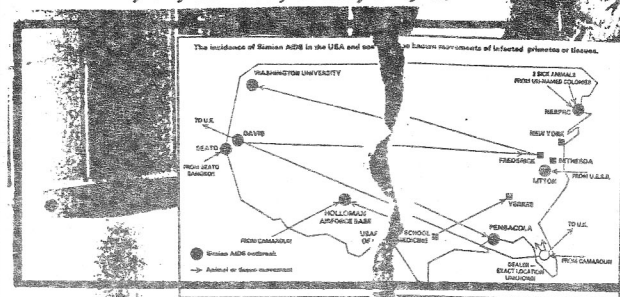
A macaque monkey in a British laboratory.

Please do not expect a reply as prisoners are restricted as to the number of letters they can write each week, and obviously they will probably want to use these to keep in touch with people they knew before entering prison.

If you write to, or telephone, the prison authorities to make enquiries or to protest about something, please do not be abusive as they come back may be on the prisoner.

S.A.R.P.'s aims are:-

1. Distribution of up-to-date information to enable those outside to write to the prisoners, and also to the governors of prisons to demand that prisoners are given vegan food, toiletries and clothing on request.
  2. To provide funds for magazines, newspapers, books and radios for prisoners, and for the travel costs of visitors on low incomes.

5 people were arrested on Jan 19th in Toronto for allegedly spray painting a Kentucky fried Chicken shop. Instead of just being charged with this they have been charged with many and more serious charges. They are all out on bail but need donations to pay for lawyers. 3 Activists were arrested in March 87 in Australia for a raid on a battery farm. They are the 1st people in Australia to be charged with animal rights offences and need donations to pay for lawyers. Below is a letter to S.E.R.P. from the vegan society:- We have now been informed by the Home Office that-"On the question of membership, there is no obligation for all vegan inmates to join the vegan society. For example, if an inmate on first reception into prison claims to be a vegan he/she can be treated as such without further enquiry. However there may be occasions where an inmates commitment to veganism is in doubt and proof of membership to the V.S. may be required to authenticate his/her position. The classic case is the inmate who suddenly requests a vegan diet during the currency of the sentence" and that "There is an adequate range of clothing available for vegan inmates which is not animal related and depending on local circumstances, Governors may allow Vegan inmates to obtain vegan toiletries through the prison canteen."

## RESISTANCE AND STRENGTH

If the state becomes increasingly totalitarian in its policies then we must increase dissent against it. It is obvious that more arrests will occur as the wealthy elite and their protectors attempt to quell all forms of unrest and rebelliousness by imposing stiff fines and sentences on the unlucky people that they catch.

Bust funds are used to support change by helping to pay fines etc for those carrying out activities of resistance but will not support any activities arranged by the political right or left wings. The funds help in a wide range of things (apart from the Newcastle and Durham bust fund who only help those involved with animal liberation) which is important if we are to pull together against what is happening to us.

# SHOPPING WITHOUT MONEY

"FREE LIVING IN A CONSUMER CULTURE"

Shoplifting has nothing to do with criminality and if you exercise a certain amount of discretion when you decide what to steal and who to steal from then the possibilities are limitless. People, who directly stand to lose from our activities of reclaiming goods, desperately try to discredit the reasons why shoplifting occurs. The media portrays shoplifters as being petty criminals, so therefore the attitudes that the general public possess are similar ones, and that is that shoplifters deserve only the utmost contempt and dislike. Survival in the consumer age isn't easy so hopefully this might explain the reasons why people shoplift and how, in one way, we can all attempt to "hold our own" in a very competitive and exploitative atmosphere.

Shoplifting is very common but because it's so easy to accomplish then we remain largely unaware of it. It would be a lot more common if many more people could overcome

their barriers to it, which were instilled by conditioning from many outside influences, overcome their own fear of getting caught, or simply if they could learn how to do it. Just think.....if you're a bit skint, you need something and the risk factor is low then you'd most probably have a go, right?

People shoplift not mainly because they are compulsive thieves but because they are poor or relatively hard up. Shoplifting, when done properly, can make ends meet and make our money stretch just that little bit further. It makes good economical sense and therefore allows us to spend money on other things, which are normally prevented from us by our society, money which would normally be spent struggling to exist. No one wants to become a prisoner of the poverty trap and shoplifting is just one practical way to help ourselves out of the shit that we often find ourselves in through no fault of our own.

We live in a culture that is deliberately exploitative. It is a consumer culture that denies wholeness of self. It has its roots in producing a thousand different varieties of the same mindless rubbish which we are convinced, through television and other forms of advertising, are essential to our existence.

While people spend their lives busily consuming all manner of crap, the people who condemn shoplifting make more and more money. It's so easy to shoplift and as long as you're careful and not reckless in any way then you can get away with anything. It's an easy skill to cultivate and when practiced regularly can become almost infallible - but never become over confident, that is when most people get caught. Remember that getting caught isn't quite as bad as it seems. Often people are left off with just a caution and it is possible to get yourself out of the shit altogether by using a false name, but if you do eventually get done it's not the end of the world because if you've nicked more in value than the fine, you're quids in!

This is not supposed to be an in-depth guide to shoplifting, it's just a brief summary making the most important points more obtrusive. So before you go ahead and attempt anything, just think a lot about what is written and the conclusion that you come to will most probably be more valid to you than a million words that I could write.

We all often get the urge to nick something when the proverbial backs are turned, but it can work to ones benefit if a bit of forward planning and forethought is put into things before hand.

Just suss the place out, escape routes, openness of situation etc and generally have a good scan.

All shops have different pros and cons, advantages and disadvantages.

Always check the layout of stores as a blindspot doesn't necessarily have to be up the arse of an assistant. Security can pose a problem but that still leaves us with a 99% chance of getting away with the booty.

Cameras are mainly employed as a deterrent as they are rarely watched and they have a narrow field of view. Don't actually rob anything in view of the camera but pick the goods up and stick them away out of the cameras view. If you do have to nick something in front of a camera turn your back to it (if possible) and remember that video film cannot be used in court.

You may find beepers and tags and other things attached to the item you wish to lift, so pull the offending article off while out of sight and then leave the store. Make sure that every device is taken off. Mirrors are usually crap but don't take them for granted and keep an eye out for 2-way mirrors. Store detectives are most probably the most

effective anti-shoplifting strategy that stores can employ. If you spot one, let them know that you've discovered their little game and they should try and act as if they don't know what you're on about and walk off but that isn't always the case. Many shops have bogus store detective warning notices.

It's important to stay very alert for store detectives. We've found that it's advisable to hang about just inside the store for a few fleeting moments when we've lifted something as unnoticed store detectives may be waiting to grab you as soon as you leave the premises. "YOU CAN'T BE NICKED FOR SHOPLIFTING UNTIL YOU HAVE LEFT THE SHOP".

It's also advisable to dress not too outlandish, as your chances are greatly improved if you can blend in successfully, and don't wear anything too tight. (very inoffensive, little things can cause intense pain when placed, for instance, down a pair of tight trousers.)

It can often be quite beneficial to lift with a partner or with a group of you. It gives you more confidence and others can act as decoys, lookouts etc. Basically, it's nice to be with others.

## IN THE EVENT...

If in the unlikely or likely event that you are arrested, the golden rule applies to all aspects of your contact with the police - do not say anything at all, just give you

ur name and address and leave it at that - and demand a solicitor. Having the knowledge and confidence to enable you to give a false name to the police can come to be terribly handy. Sort out your false name before hand to avoid any incompetent cock-ups on your behalf. The most important detail is to give an incorrect date of birth. Give the address

of someone who will vouch for you living there if the police come round when they need to authenticate your claim of living at that address. When the court case comes up and you don't turn up for it, the police may come round to apprehend you, and your accomplice will tell them of your departure from the household and explain that they don't know your new address. Make sure before hand that you know everything word perfect and have sorted yourselves out reasonably enough. This does work and is proven so remember that and get your confidence up (you'll need it!)

## IT'S UP TO YOU!

The shop is what has to fork out money for the stolen object but usually amounts to something comparative to a flea bite. It's hardly being ripped off. But it is exactly the glossy high street boutiques of excessiveness that deserve to be mercilessly ripped off for parading the cause of our poverty. They deserve to be well and truly attacked for the promotion of consumerism which cons people into believing that they must have more than they actually need. "If you have not got a brand new electronic shitting machine etc etc etc... you're not a complete human being".

Why should we experience guilt or even the smallest moment of remorse for our actions? We have equalised the situation a little and have alleviated some of the weight of this modern world off our shoulders and lives. There is nothing wrong with doing that when the capitalis

ts and liemongers, who keep us in positions of poverty, live in total luxury. Their greed and inevitable obesity of possessions directly stems from the exploitation of the people. They enjoy life because they have stolen ours off us. They experience no feelings of guilt at doing that so why should we, when we start to take control of our increasingly sad lives and reclaim what is rightfully ours.

Throughout our lives we are conditioned to accept the morals and standards that dictate to us the social norm. This normality is shit, it's consumerism, which is just one facet of our diseased society. We are compelled to buy even the most unnecessary of commodities so that we may feel complete in this very incomplete society. Who benefits? Certainly not us. The bosses, the smart and secure executives, the governments, the multi-national corporations and their whole grey world of corruption and exploitation are what benefit from the blatant abuse of us. We have to work and produce these goods, they make the profits and we consume the rubbish. Why should we feel guilty at fighting back against it all and making a conscientious attempt at improving our existences.

We are poor and this is a deliberate result of our society. Shoplifting is just one small way of expressing our will to deny the exploitation of ourselves and of others by the ruling classes who ultimately benefit from our poverty.

It's making our lives real and livable. We should never

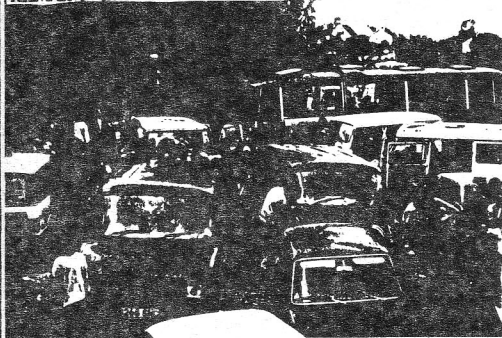

## STONEHENGE

Since this festival was banned, more and more people have begun to realise the injustice and hypocrisy of council and police policy and have made serious steps to hold a festival at the actual stones and to help and assist the many people that see a festival at Stonehenge a viable proposition. There hasn't been a festival at the site since 1984, however, every year since 1984, small mini festivals have occurred with increasing frequency around Wiltshire on the Solstice weekend, Westbury in 1985, Hanging Langford in 1986 and

in 1987, so it is important to stress that even though Stonehenge doesn't witness a festival, many other places do and, besides the political implications for the stones, all the more reason to "go for it" on the solstice weekend.

Others are:-

### BRAMBLES FARM FESTIVAL

near Waterlooville in Hampshire. Originally, the festival was a peace camp next to the Marconi weapons factory, hence the "torpedo town" nickname. Although the festival is no longer at the original site it still retains the name.

### ROLL RIGHT STONES

festival near Chipping Norton in Oxfordshire. This festival had an extremely dubious start with a lot of attention off the authorities who eventually forced the landowner

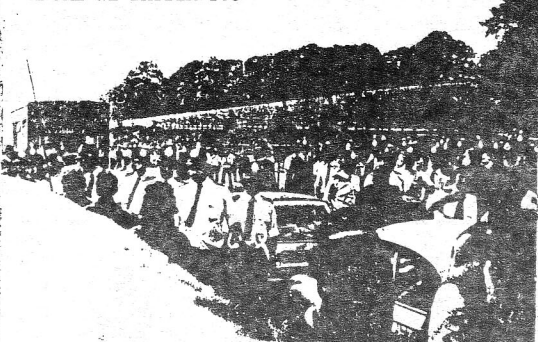

Well, what is a festival? Is it somewhere where people can meet and live together in peace and harmony, for a certain length of time, as a demonstration of what can be achieved through a minimum amount of effort or is it someplace where people can obtain cheap drugs and generally act out their shithead-ish roles in a different scenario? I prefer to believe that the former is nearer the truth and that there are people who are prepared to work towards a situation that is worthwhile, positive in its outlook and, most importantly, constructive.

A true festival is essentially free with more emphasis put on bartering and free exchange than money. It is also important that festivals occur away from cities as built up areas typify most the greed, vindictiveness and aggression that festivals seek to combat.

Free festivals can be examples of alternative culture, where freedom and space are in endless supply and therefore makes facility for people to be creative in a co-operative atmosphere, a place where people can work together towards some where that others can relax, be happy and be nice to each other. On the same side of the fence as the state are the festivals who revel in bondage and whose motives are simply to make profit for a small few. The utmost contempt should be reserved for these exploitative, so called festivals as they only exist to further the interests of a money-minded minority. Donington, Reading etc and, the lesser of the evils, Glastonbury often have huge turn-outs but these should not be confused with true festivals and the motives of true festivals.

to curtail the plans for the festival, though it did go ahead.

#### TWMBARLWM

festival, Gwent, which was effectively stopped by the authorities during 1987. The usual tactic of "divide and conquer" was employed successfully and a potentially large gathering was kept in fragments.

#### MENWITH HILL

festival, near Otley, West Yorks. This doubles as a permanent peace camp against the U.S. spy base (the largest in Europe) which happens to be situated next door. Strangely enough, the M.O.D. tolerate a festival and even keep a fairly low profile.

That is a rough guide to the main free festivals that occur in Britain to my knowledge.

(FOOTNOTE:--A lot of people romanticise about festivals and only enlarge on the good points. In reality free festivals also have their commens, cheats, profiteers, aggressors and unco-operative people. It's just that the good points concerning festivals far outweigh the bad points.)

and repressive the legal system in this country may be, but at least everyone is allowed equal access to legal help in the form of the legal aid scheme, no matter what their financial status is.

However. The government proposes new changes to the scheme in the form of a new LEGAL AID BILL, which will mean that more people will have to fork out the ridiculously high fees charged for legal help.

These changes will make it virtually impossible for a lot of people to continue with a case, as most of the time the opposition is the state, which has unlimited financial resources. In cases where direct action is involved, we all know how slowly the wheels of justice turn. The delays in these cases will mean that we will no longer be able to afford to defend ourselves and obviously more people will be convicted or wrongly convicted.

Basically the changes involved will mean that:-

People will have to pay or pay more for legal help, the longer the case, the more it will cost. = cant afford to go on.

Help with housing and D.H.S.S. will only be available through specially appointed agents, therefore people will have less choice about where to get advice from. Possibly less places giving out good advice, and less people getting good advice.

Solicitors who take on legal aid work will be paid less than for private cases. (a bit like the N.H.S.)

As a result less briefs will be prepared to take on legal aid work, and there will then be less places where people on low incomes or on the dole can get help from.

Protest music has always been a good seller. Well, enough is enough, NOBOUT is going to profit from this idea. The only difference it will make is that the money from the record sales will go to the independent labels & bands who put the effort into it in the first place. So if you use a record shop, store, stall, whatever that sells a lot of alternative records then have a word with the person who runs it & see if they're interested in dealing with indie labels & not buying their records off the Cartel catalogue, that is, if they're decent enough & not into thinking they can profit from this. If they ARE interested in dealing direct with indie labels then send their name & address to me. Also any labels or bands selling stuff get in touch. What we'll do is pass onto the shops the names & addresses of who is selling & send the shops names & addresses to the people who are selling.

The only problem is that although you're gonna get a chance to sell your records to shops up & down the country you're gonna have to sell them to the shops at catalogue prices not cover prices. So you'll have to agree a price with the shop which suits both parties. I've already got a couple of addresses of shops (only 3 so far) so I'm looking for some decent feedback on this. Also give advice to shops when they're offered records, tell them what will sell good. Don't kid yourself on, they are making plenty of money out of us.
